RESOLUTION NO. 07-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE REPEALING RESOLUTION NO. 07-14 AND RE-ESTABLISHING PERMIT PARKING ON ALL CITY STREETS IN RESIDENTIALLY ZONED AREAS DESIGNATED WITH TIME-LIMIT PARKING RESTRICTIONS

WHEREAS, the City Council of the City of La Cañada Flintridge realizes that time-limit parking restrictions on certain streets in residentially zoned areas creates an inconvenience and hardship to the residents of those streets; and

WHEREAS, the City Council of the City of La Cañada Flintridge also realizes the importance to the general health, safety, peace and welfare of the community to maintain time-limit parking restrictions on certain streets in residentially zoned areas; and

WHEREAS, the City has developed a parking permitting mechanism which will satisfy the needs of residents while at the same time allow for the enforcement of parking restrictions; and


WHEREAS, the Public Works and Traffic Commission has recommended the proposed changes to the permit parking allocation system;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE DOES HEREBY RESOLVE AS FOLLOWS:

1. Resolution 07-14 is hereby repealed.
2. Permit parking is permissible on all City streets within residentially zoned areas that have been designated with time-limit parking restrictions and for which permit parking is intended as identified in Exhibit A, attached hereto and incorporated herein. All vehicles displaying the appropriate parking permit decal shall be considered exempt from the time-limit parking restriction. In addition, vehicles involved in the following activities shall be considered exempt from the time-limit parking restrictions:
 - A. Necessary loading and unloading;
 - B. Performing a service activity on the adjacent lot or parcel of land;
 - C. A lawful commercial use on the adjacent lot or parcel of land;
 - D. The construction of buildings or structures on the adjacent lot or parcel of land; or
 - E. The construction or maintenance of a highway or alley.

3. Upon application in each calendar year, up to two annual resident parking permit decals and up to four annual guest permit decals shall be issued to each City residence that abuts a street, road, highway, avenue, alleyway or other arterial, which has been designated in Exhibit A herein. The street to which the permit is registered shall be noted on the permit and each permit shall only be valid for the street to which it is assigned.
4. A resident may obtain more than two annual resident parking permit decals upon a showing of need by demonstrating that parking facilities on the residential property are inadequate and/or not feasible or that the imposed parking restriction creates an undue hardship.
5. Residents of time-restricted streets who wish to obtain parking permit decals shall be required to complete an "Application for Parking Permit" form, which shall be held on file by the City.
6. Parking permit decals are valid only for the period of January 1 through December 31 of the calendar year. All parking permit holders shall be required to re-apply annually for parking permit decals.
7. This resolution shall take effect on July 30, 2007.



EXHIBIT A

IDENTIFICATION OF CITY STREETS IN RESIDENTIALLY ZONED AREAS DESIGNATED WITH PERMIT PARKING RESTRICTIONS

The following streets, roads, highways, avenues, alleyways or other arterials have been identified as eligible for permit parking exception to designated time-limit parking restriction:

<u>STREETS</u>	<u>RESTRICTION</u>
Alminar Avenue	1-hour Parking Only – 8:00 a.m. to 3:00 p.m. School Days only between Daleridge Road and Baptiste Way
Belita Lane	1-hour Parking Only – 7:30 a.m. to 4:30 p.m. School Days Only between Lamour Drive and Viro Road (Revised 7/30/07)
Daleridge Road	2-hour Parking Only – 8:00 a.m. to 3:00 p.m. School Days Only between Foothill Boulevard and Baptiste Way
Foothill Boulevard	No Parking on Street Between 2:00 a.m. and 5:00 a.m.
Hobbs Drive	2-hour Parking Only – 8:00 a.m. to 8 p.m. Monday through Saturday
Lamour Drive	1-hour Parking Only – 7:30 a.m. to 4:30 p.m. School Days Only between Viro Road and Alveo Road (Revised 7/30/07)
Lasheart Drive	2-hour Parking Only – 7:00 a.m. to 6:00 p.m. Monday through Saturday
Viro Road	1-hour Parking Only – 7:30 a.m. to 4:30 p.m. School Days Only between Foothill Boulevard and Belita Lane (Revised 7/30/07)
Alveo Road	1-hour Parking Only – 7:30 a.m. to 4:30 p.m. School Days Only between Lamour Drive and Viro Road (Added 7/30/07)

The following streets, roads, highways, avenues, alleyways or other arterials have been identified as eligible for permit parking exception to designated “No Parking Except by Permit” restriction:

<u>STREETS</u>	<u>RESTRICTION</u>
Encinas Drive	Tuesday and Thursday between Verdugo Boulevard and Shepherd's Lane
Homewood Lane	Tuesdays and Thursdays
Lanterman Lane	Tuesdays and Thursdays east of Encinas Drive
