

**RESOLUTION NO. 09-18**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE AUTHORIZING THE RELOCATION OF AN EXISTING MARKED CROSSWALK ON LA CAÑADA BOULEVARD AT SALISBURY ROAD**

WHEREAS, the relocation of the existing marked crosswalk across La Cañada Boulevard at the intersection of Salisbury Road from the south leg to the north leg as part of scheduled street reconstruction has been justified by an Engineering and Traffic Study, attached hereto and incorporated herein; and,

WHEREAS, prior to the removal of any marked crosswalk, Section 21950.5 of the Vehicle Code of the State of California requires a public notice and posting at the crosswalk location at least 30 days prior to the scheduled date of removal to give all users the opportunity to be heard and consider any possible objections; and,

WHEREAS, the notice required by the aforementioned section of Vehicle Code shall include an explanation that the public may provide input relating to the scheduled removal, as well as the form and method of providing such input; and,

WHEREAS, the City published a notice of a public hearing in the local newspaper and posted the crosswalk location pursuant to the aforementioned section of the Vehicle Code; and,

WHEREAS, the City Council has held a public hearing and considered all opinions regarding the relocation and/or removal of crosswalks at the intersection of La Cañada Boulevard and Salisbury Road.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:

1. The City Council of the City of La Canada Flintridge, pursuant to Sections 21950.5 of the Vehicle Code of the State of California, finds that the relocation of the existing marked crosswalk across La Cañada Boulevard at the intersection of Salisbury Road from the south leg to the north leg is required in order to protect public health and safety.
2. The City Council does hereby determine and declare that the marked crosswalk shall be relocated and/or removed as provided in Section 1 of this Resolution.
3. The City Council does hereby authorize and direct the installation and/or removal of marked crosswalks at said location for the controlling of pedestrian traffic as provided in Section 1 of this Resolution.
4. The establishment and enforcement of related crossing regulations shall not become effective until said crosswalks have been installed and/or removed at said intersection.
5. The City Clerk shall attest to the passage of this resolution and it shall thereupon be in full force and effect.
6. This resolution shall take effect on July 6, 2009.
