

**RESOLUTION NO. 09-37**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
LA CAÑADA FLINTRIDGE DECLARING THE 16<sup>th</sup> ANNUAL  
THANKSGIVING DAY RUN AND FOOD DRIVE AS A SPECIAL EVENT**

**WHEREAS**, the Community Center of La Cañada Flintridge annually organizes a Thanksgiving Day Run and Food Drive Fund Raising Event (formerly known as the "Thanksgiving Day Run for the Hungry") that benefits local homeless shelters and organizations that assist the needy in surrounding communities; and,


**WHEREAS**, this is the 16<sup>th</sup> Annual Thanksgiving Day Run and Food Drive that will take place on November 26, 2009, and will draw approximately 1,000 participants and 500 spectators to the event; and,

**WHEREAS**, the City of La Cañada Flintridge has received a request that the City provide certain services and declare the function a Special Event; and,


**WHEREAS**, pursuant to Chapter 4.05 of the La Cañada Flintridge Municipal Code relating to the Regulation of Parades and Special Events in the Public Right-of-Way, those streets comprising of the route of the event, as set forth in the Special Event Permit Application, be closed on November 25, 2009, from 5:00 A.M. to 12:00 noon along Foothill Blvd (west & east bound), between Angeles Crest Highway and Ocean View Blvd and along La Cañada Blvd, between Foothill Blvd and Fairview Drive subject to the supervision of the Director of Public Works;

NOW, THEREFORE, be it resolved that the City Council of the City of La Cañada Flintridge does hereby declare the 16<sup>th</sup> Annual Thanksgiving Day Run for the Hungry that will take place on November 26, 2009, as a Special Event.


