**A RESOLUTION OF THE CITY COUNCIL OF
THE CITY OF LA CAÑADA FLINTRIDGE ESTABLISHING CERTAIN FEES
FOR CITY SERVICES FOR A ONE YEAR PERIOD FROM
FEBRUARY 1, 2010 TO JANUARY 31, 2011**


WHEREAS, the City Council is desirous of reducing certain fees of the City of La Cañada Flintridge in a manner that will help stimulate the local economy; and

WHEREAS, the City Council believes that a reduction of these fees for a period of one year is appropriate given the current condition of the local and regional economy

NOW, THEREFORE, BE IT RESOLVED, that the City Council does hereby adopt the fees as identified in Attachment B, and incorporated herein;

BE IT FURTHER RESOLVED, that the fees identified in Attachment B shall be in effect for a period of one year, from February 1, 2010 through January 31, 2011. After this one year period, these fees shall return to the level at which they were as of the date of the adoption of this Resolution, unless as directed otherwise by subsequent City Council Resolution.

Design Review - Signs	\$780 per application	50% reduction in application fee	\$390 per application	\$6,630.00	It is plausible that a 50% reduction in the Sign Review application fee could encourage more business owners currently located in La Cañada Flintridge to modify their signage, although this is not a large incentive (a one-time savings of \$390)
Design Review	\$500 per application, plus \$1,210 in additional fees, for a total fee of \$1,710	50% reduction in application component of fee	\$250 per application (no change in other components of fee)	\$2,250.00	It is plausible that a 60% reduction in the Sign Review application fee could encourage more business owners currently located in La Cañada Flintridge to modify their signage, although this is not a large incentive (i.e. a one-time savings of \$250).
