

**RESOLUTION NO. 10-06**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA  
FLINTRIDGE ESTABLISHING "NO PARKING ANYTIME" RESTRICTIONS ON  
PORTIONS OF ALTA CANYADA ROAD, HILLARD AVENUE, LA CAÑADA  
BOULEVARD, PALM DRIVE AND VISTA DEL VALLE ROAD

WHEREAS, Section 22507 of the Vehicle Code of the State of California authorizes local authorities to adopt rules and regulations by ordinance or resolution with respect to the prohibition or regulation of parking on its streets including preferential parking privileges, and


WHEREAS, the Public Works & Traffic Commission and City Council have found that parking restrictions on certain street segments named in this Resolution are needed based on the recommendation of the City Traffic Engineer, and

WHEREAS, the City Council of the City of La Cañada Flintridge also realizes the importance to the general health, safety, peace and welfare of the community to maintain two-way traffic circulation and improved emergency access on certain collector streets.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:

1. Pursuant to Section 4.04.047 of the La Cañada Flintridge Municipal Code, the City Council of the City of La Cañada Flintridge does hereby determine and declare that parking is hereby restricted as follows:
  - a) No Parking Anytime on west side of Alta Canyon Road from Foothill Boulevard northerly up to 200 feet.
  - b) No Parking Anytime on the east side of Hillard Avenue from Foothill Boulevard to 4727 Hillard Avenue.
  - c) No Parking Anytime on the east side of Palm Drive from Foothill Boulevard northerly up to 200 feet.
  - d) No Parking Anytime on South Side of Vista Del Valle Road and Red Curb on North Side of Vista del Valle Road from Vista Lejana Lane easterly 70 feet.
2. The City Council does hereby authorize and direct the installation of parking signs as provided in Section 1 of this Resolution.
3. The establishment and enforcement of said parking restrictions shall not become effective until official parking signs have been posted on said streets.
4. The City Clerk shall attest to the passage of this resolution and it shall thereupon be in full force and effect.
5. This resolution shall take effect on February 1, 2010.


