

RESOLUTION NO. 10-15

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE ESTABLISHING A STOP CONTROL IN THE WESTBOUND DIRECTION OF TULIP TREE LANE AT THE INTERSECTION OF CROSS STREET AND ROSEBANK DRIVE

WHEREAS, Section 21100 of the Vehicle Code of the State of California authorizes local authorities to adopt rules and regulations by ordinance or resolution with respect to regulating traffic by means of official traffic control devices including stop signs; and

WHEREAS, Section 21101 of the Vehicle Code of the State of California authorizes local authorities to adopt rules and regulations by ordinance or resolution with respect to: (1) the designation of any highway as a through highway, and requiring all vehicles to observe official traffic control devices before entering or crossing that highway; and (2) the designation of any intersection as a stop intersection, and requiring all vehicles to stop at one or more entrances to an intersection; and

WHEREAS, the installation of a stop sign in the westbound direction of Tulip Tree Lane at the intersection of Cross Street and Rosebank Drive has been justified by an Engineering and Traffic Study, on file in the Public Works Department;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:


1. The City Council of the City of La Cañada Flintridge, pursuant to Sections 21351, 21354, 21355 and 21360 of the Vehicle Code of the State of California, finds that the westbound approach of Tulip Tree Lane at the intersection of Cross Street and Rosebank Drive necessitates stop controls in order to protect public health and safety.
2. The City Council does hereby determine and declare that stop control(s) shall be established as provided in Section 1 of this Resolution.
3. The City Council does hereby authorize and direct the installation and maintenance of stop control(s) at said location for the controlling of traffic as provided in Section 1 of this Resolution.
4. The establishment and enforcement of said stop control regulations shall not become effective until said stop control(s) have been posted at said intersection.
5. The City Clerk shall attest to the passage of this resolution and it shall thereupon be in full force and effect.
6. This resolution shall take effect on May 3, 2010.
