RESOLUTION NO. 11-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE AUTHORIZING THE ISSUANCE OF A RECREATIONAL FACILITY PERMIT TO LA CAÑADA BASEBALL/SOFTBALL ASSOCIATION FOR USE OF THE FIS LOWER FIELD AND CORNISHON FIELD ON SUNDAY, JUNE 26, 2011.

WHEREAS, the La Cañada Baseball/Softball Association (LCBSA) was successful in securing a bid and hosting the ASA youth baseball and softball tournaments in the City of La Cañada Flintridge in June/July 2010; and

WHEREAS, due to the tournament's success LCBSA wishes to hold another baseball tournament, on the weekend of June 25-26, 2011, will attract approximately 45 baseball teams from throughout Los Angeles County; and

WHEREAS, the Tournament requires LCBSA to utilize all City Joint Use fields in order to accommodate the number of participants the tournament will draw from around the San Gabriel Valley and beyond; and

WHEREAS, for over 56 years LCBSA has provided the opportunity for youth to participate in a baseball and softball; and

WHEREAS, the LCBSA has been a good partner with the City by providing numerous Recreational Facility Improvements with approximately \$37,500 in improvements performed in 2011 to date; and

WHEREAS, on May 11, 2011, the La Cañada Flintridge Parks and Recreation Commission conducted a public hearing regarding Sunday usage by LCBSA on Sunday, June 26, 2011, a staff report and public testimony was received, and the Commission voted 5-0 in support of the Sunday usage request by LCBSA for the FIS Lower and Cornishon Fields; and

WHEREAS, given the lack of available athletic field space, availing Sunday use of the FIS Lower and Cornishon Fields will alleviate congestion, over-crowding and will help stimulate the local economy through increased sales and sales tax generation as set forth in the corresponding staff report; and

WHEREAS, based upon the recommendation of the Parks and Recreation Commission the following protections for residents surrounding the FIS Lower and Cornishon Fields shall be implemented as follows:


1. Provide temporary "No Parking except by Permit" restrictions on lower Cornishon Avenue (South of the Athletic Fields) between 8:00 a.m. and 5:00 p.m. on June 26, 2011.
2. Provide temporary parking permits to the affected residents allowing them to park in the restricted parking zone.

3. Post "Tournament Parking Here" signs at the surface parking lots available at the Lanterman Auditorium and the School District Offices.
4. Request that LCBSA assign a "Parking Monitor" during the game start times to direct tournament attendees away from the residential areas along lower Cornishon Avenue.
5. Prohibit LCBSA's usage of an amplified PA system during the Sunday usage.
6. Request that LCBSA perform a diligent cleanup of the fields at the conclusion of the Tournament.

NOW, THEREFORE, based on the findings and recitals above, the City Council of the City of La Canada Flintridge hereby resolve and order as follows:


1. That the recitals set forth above are incorporated herein as findings by the City Council.
2. That upon the satisfaction of the six conditions set forth above, the City Council shall authorize a recreational facility permit and fee waiver request in the amount of \$175.00 for La Cañada Baseball/Softball Association to use the Lower FIS and Cornishon Fields on Sunday, June 26, 2011.


