**RESOLUTION NO. 12-19**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE AUTHORIZING THE CITY MANAGER TO ACCEPT THE SIDEWALK EASEMENT DEDICATION ASSOCIATED WITH THE UNION 76 GAS STATION/7-ELEVEN CONVENIENT STORE PROJECT (1001 FOOTHILL BOULEVARD) AND AUTHORIZING STAFF TO FILE FOR RECORDATION THE EASEMENT DOCUMENTS WITH THE LOS ANGELES COUNTY RECORDER**

WHEREAS, the Planning Commission of the City of La Cañada Flintridge adopted Resolution 10-39 approving the development of the Union 76 Gas Station/7-Eleven Convenient Store Project on July 13, 2010; and

WHEREAS, the conditions of approval required the dedication of an easement for sidewalk purposes on Foothill Boulevard to comply with ADA (Americans with Disabilities Act of 1990) requirements; and

WHEREAS, the City Council of the City of La Cañada Flintridge desires to facilitate the construction of the Union 76 Gas Station/7-Eleven Convenient Store Project; and

WHEREAS, the City Council of the City of La Cañada Flintridge desires to accept the sidewalk easement dedication free and clear of any easements; and

WHEREAS, the City Council of the City of La Cañada Flintridge has vested signatory authority to the City Manager for numerous projects;


