**RESOLUTION NO. 12-27**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE SUPPORTING SB 204 (LIU/GATTO) REGARDING EXCESS PROPERTIES ALONG THE SR-710 CORRIDOR AND SOUNDWALL FUNDING**

**WHEREAS**, SB 204 has been passed by the state legislature and forwarded to Governor Brown's Office for signature; and

**WHEREAS**, SB 204 requires the California Transportation Commission (CTC) and Caltrans to declare as excess state properties, the surface estates of certain properties which exist in the cities of Pasadena, South Pasadena, Alhambra and Los Angeles, and which were acquired for the State Route 710 surface freeway extension and would require Caltrans to expeditiously release those properties for sale, and

**WHEREAS**, SB 204 provides that no proceeds from the sale of the excess properties may be used on any activity to advance any subsurface alternative for the SR-710 North Gap Closure Project; and

**WHEREAS**, SB 204 authorizes Metro, in consultation with Caltrans and only if acting jointly with the cities in which excess properties are located, to develop and file with the CTC a local alternative transportation improvement program that addresses transportation problems and opportunities within the SR-710 Project Study Area; and

**WHEREAS**, SB 204 specifies that the proceeds from the sale of the excess properties shall be allocated by the CTC to fund the approved local alternative transportation program, provided that not less than 25% of those proceeds are allocated to the construction of soundwalls on SR-210 between SR-2 West and SR 19 South; and

**WHEREAS**, SB 204 provides some state funding for soundwalls in the City of La Cañada Flintridge, which is long overdue and which, decades ago, should have been funded from state funds as other soundwall projects were.

**NOW, THEREFORE**, be it resolved that the City of La Cañada Flintridge supports SB 204 and encourages the Governor to sign the bill into law.
