RESOLUTION NO. 12-33

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE ESTABLISHING "NO PARKING 8:00 TO 9:15AM, 1:30 TO 3:30PM SCHOOL DAYS ONLY" RESTRICTIONS ON THE SOUTH SIDE OF FAIRVIEW DRIVE FROM ANGELES CREST HIGHWAY WESTERLY 85 FEET, AND RESCINDING RESOLUTION NO. 09-55.

WHEREAS, Section 22507 of the Vehicle Code of the State of California authorizes local authorities to adopt rules and regulations by ordinance or resolution with respect to the prohibition or regulation of parking on its streets including preferential parking privileges, and

WHEREAS, the Public Works & Traffic Commission and City Council have found that the said parking restrictions are needed based on the recommendation of the City Traffic Engineer, and

WHEREAS, the City Council of the City of La Cañada Flintridge also realizes the importance to the general health, safety, peace and welfare of the community to maintain two-way traffic circulation and improved emergency access on certain street segments.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE DOES HEREBY FIND, DETERMINE AND RESOLVE AS FOLLOWS:

1. Resolution No. 90-55 establishing time limit parking restrictions on the south side of Fairview Drive west of Angeles Crest Highway is hereby rescinded.
2. Pursuant to Sections 4.04.047 and 8.10.020 of the La Cañada Flintridge Municipal Code, parking is hereby restricted as follows:
 - a. "No Parking 8:00am to 9:15am, 1:30pm to 3:30pm School Days Only" on the south side of Fairview Drive from Angeles Crest Highway westerly 85 feet on School Days Only.
3. The City Council does hereby authorize and direct the installation of parking signs as provided in Section 2 of this Resolution.
4. The establishment and enforcement of said parking restrictions shall not become effective until official parking signs have been posted on said streets.
5. The City Clerk shall attest to the passage of this resolution and it shall thereupon be in full force and effect.
