**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA CAÑADA FLINTRIDGE AMENDING RESOLUTION 07-10 TO ADD FEES FOR PROCESSING OF DIRECTOR'S REVIEW FOR RECREATIONAL VEHICLE PERMIT APPLICATIONS**

**WHEREAS**, on March 4, 2013, the City Council of the City of La Cañada Flintridge adopted Ordinance No. 410, pursuant to which the City created a permit requirement for the parking of recreational vehicles; and

**WHEREAS**, the City Council now desires to amend the City's Fee Schedule, as adopted by Resolution No. 07-10, to add fees for recovery of the administrative cost of processing recreational vehicle permit applications.


**NOW, THEREFORE, THE CITY COUNCIL DOES HEREBY RESOLVE AS FOLLOWS:**

Section 1. The City's Fee Schedule, as adopted by Resolution No. 07-10, is hereby amended to add the following fees:

Type of Fee	Amount of Fee
Application for Director's Review Recreational Vehicle Permit (May 21, 2013 thru December 31, 2013)	\$0.00
Application for Director's Review Recreational Vehicle Permit (January 1, 2014 thru June 30, 2014)	\$75.00
Application for Director's Review Recreational Vehicle Permit (July 1, 2014 until repealed or modified by further action of the City Council)	\$200.00

Section 2. The fees adopted herein shall remain in effect until such time as it is repealed or modified by further action of the City Council.
