



**MINUTES OF THE REGULAR MEETING
OF THE CITY OF LA CAÑADA FLINTRIDGE
PARKS & RECREATION COMMISSION
HELD ON WEDNESDAY, MARCH 9, 2016**

PRELIMINARY BUSINESS

1. Call to Order

Chair Jim Kambe called the meeting to order at 6:02 p.m.

Commissioner Kamar stated his receipt of a letter from the Misplaced Priorities regarding not being booked for the upcoming Music in the Park Concert Series.

Senior Management Analyst Parseghian stated at the February meeting, staff brought for review the schedule of the last three years Music in the Park lineups to the Commission for input. He stated the Commission identified bands they would like to see return for 2016 and those they would like to not have in the schedule for at least one year to provide more variety. However, Misplaced Priorities was not mentioned on either list. He stated there is never a guarantee that a band from a prior season will play in the concert series due to many factors including, scheduling conflicts, lack of interest from the bands, availability limitations, and maintaining variety. He stated staff secured the bands identified by the Commission and filled the remaining slots with other talents.

Chair Kambe stated his desire to make sure the minutes are accurate. Senior Management Analyst Parseghian stated staff will go back and re-verify that Misplaced Priorities was not discussed by the Commission.

Commissioner Koblin asked whether the Commission could reconsider the band for this year's schedule. Senior Management Analyst Parseghian stated that all contracts for the 2016 Music in the Park have been signed and executed. He stated at this point there couldn't be a reconsideration of any bands. He re-stated the review of the minutes would only be to re-verify that the Misplaced Priorities was not mentioned. He also stated the Commission could approve the minutes

contingent upon re-verification of any mention of the Misplaced Priorities.
