He stated having businesses run the activity would not be possible as they do not represent the City. He explained, the Community Center has always fulfilled the role of City's recreational program.

Commissioner Kambe recommended partnering with the Community Center to showcase the different recreational programs available at the Community Center through a multi-week activities program.
